After years of waiting, 24 humanitarians will return to trial tomorrow, reflecting the recent trend in EU of persecuting humanitarians to discourage solidarity. They are facing accusations including smuggling, membership in a criminal organisation, money laundering and espionage.

Bar associations and human rights organisations alike have emphasised the lack of legal basis for the trial.

Human Rights Watch has stated that: "the Greek authorities' misuse of the criminal justice system to harass these humanitarian rescuers seems designed to deter future rescue efforts, which will only put lives at risk".

We express our grave concern about the charges that have been filed against Sean, Sara, Nassos and 21 others.

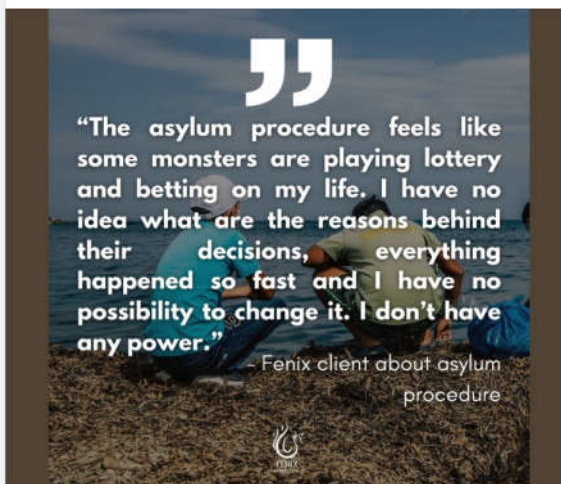



34 other people seeking safety have been rescued following the shipwreck so far.

Last night, a two-month-old baby died in a shipwreck on the coast of Lesvos.

This avoidable loss of young life happened in the context of systematic violent border policies of Greece and supported by the EU.

Greece and the EU must stop their current policy and invest in safe and legal pathways.

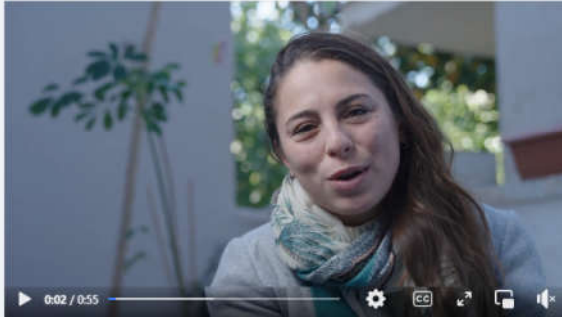

Today is Human Rights Day, and we want to take a moment to reflect and think about the refugees and asylum seekers who are living on the margins of Europe. On Lesbos, asymmetry of information is the rule. Regulations here seem ever-changing. This obstructs people arriving in Greece from accessing their right to seek asylum. We accompany our clients to their interviews and present objections to ensure their rights are respected. 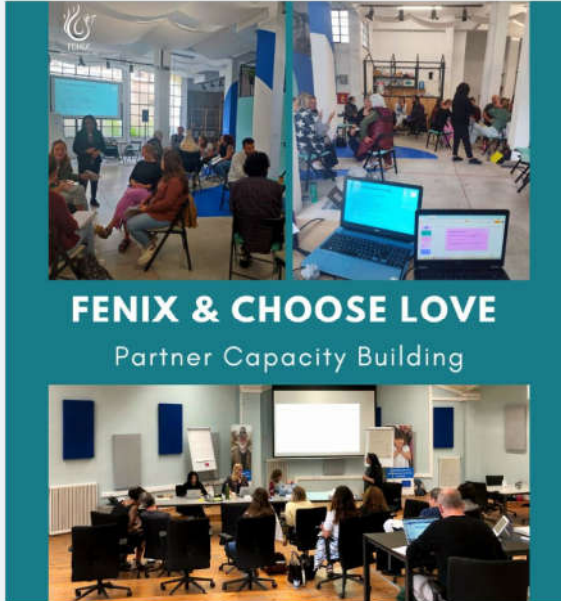

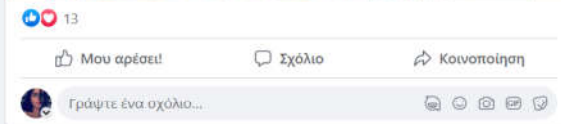

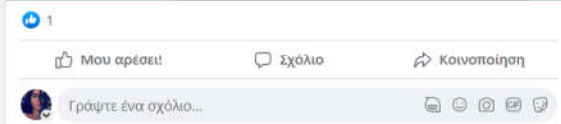

BLOG: BRIDGING CAPACITY FOR INCLUSIVITY

In the last year, we have trained over 130 participants on sexual orientation and gender identity in the context of the Greek asylum system. Through our expertise we aim to provide other actors working in this field with tools to provide well-informed and more inclusive services.

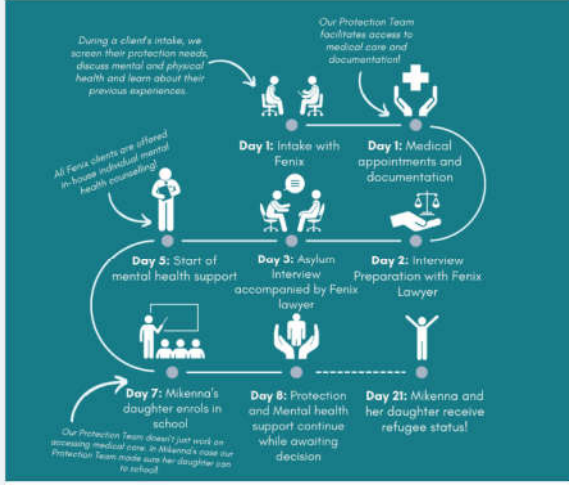

CHILDREN'S RIGHTS ARE HUMAN RIGHTS!

Throughout our work on Lesbos, we have supported over a hundred unaccompanied minors.

Through this, we have witnessed an extremely concerning trend:

Many unaccompanied children in Greece are incorrectly being registered as adults, even when they can prove they are children.

Wrongful registration leads to multiple infringements of the fundamental rights of children, such as inadequate living conditions, lack of education and procedural roadblocks, like delays in potential family reunification.

In case of doubt, minors can be referred for an age assessment. However, these are often not requested by authorities or are not properly conducted and often in violation of the required standards.

We are heartbroken by the events of last night: two shipwrecks of the Greek coast serve us as unnecessary and horrendous reminders of the effects of Greece's and Europe's violent border policies.

Our thoughts are with the families of those whose lives have been lost, and those who are still missing. We continue to urge Greece and the EU to invest in safe and regular pathways.

*update: as rescue activities are ongoing the total death toll is now 17 people, while 10 people are in hospital.



Last night, the lives of 15 women were lost as a consequence of a shipwreck near Lesbos. 9 women have been rescued, but 16 are still missing. Another ship of around 100 people also capsized on Kythira Island, and a rescue mission is still

ongoing.

These two shipwrecks didn't happen in a vacuum. They happened in the context of systematic violent border policies of Greece and supported by the EU. Seeking safety should never be a deadly endeavour. Greece and the EU must stop the current policy and invest in safe and legal pathways.

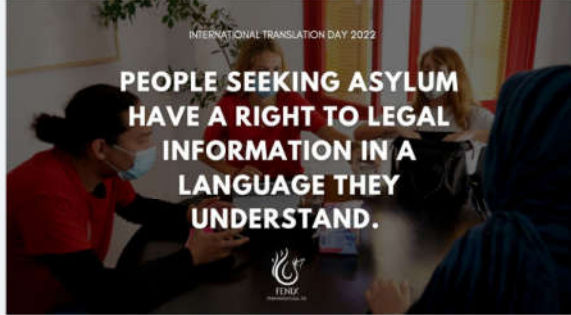

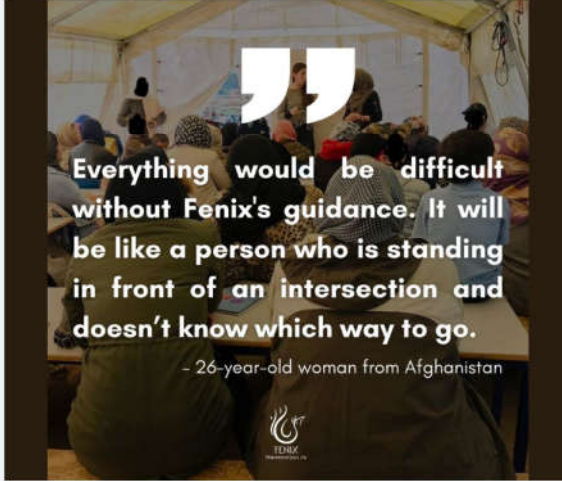

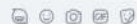

All together the Development Team is constantly working on expanding our impact and improving our services, as well as growing our mission and sharing our vision!



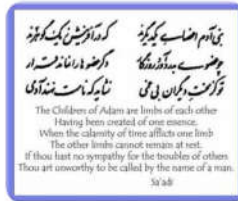

INTERNATIONAL DAY OF CHARITY 2022

Charity generally consists of the act of giving help, often through monetary, physical or professional donations, to those in need. While often good intentioned, charity, in a way, suggests pity, as it implies reaching down, instead of reaching across. Charity tends to neglect the dignity, agency and abilities of its recipients, as it is focused on generalised help, largely intended to meet people's basic needs. Yet, basic needs may strongly differ from person to person. This trend of generalisation carries on in the European asylum system. People seeking asylum are often referred to as beneficiaries and victims. This fails to take into account individual histories, sociopolitical stories and personal needs, which in turn results in people not being seen or addressed in their full complexity. Moreover, perceiving people seeking asylum as merely passive recipients of aid contributes to a pre-existing discrepancy in power, and undermines the agency and abilities of those in the asylum system. Extending charity without addressing the context in which it is provided, facilitates and potentially intensifies this power imbalance, and keeps in place disadvantages faced by people seeking international protection.

In reality, people face disadvantages due to political, attitudinal and social barriers within the asylum system. While the obstacles people seeking asylum face are caused by a larger system their effects are often deeply personal, and can vary per person. Support to people applying for asylum should therefore centre the needs and experiences of the individual. This is why the empowerment of our clients is one of Fenix's core values. In practice this means that within the context of the asylum system, which has been designed to treat asylum seekers as beneficiaries instead of agents with responsibility and decision-making power, we believe in information and knowledge as tools for agency. The focus of our work is not simply supplying people with generic services. By offering people tools, information and support in accessing the services they have a right to, we work together with our clients to empower them to take back control over their legal process. This emphasis on empowerment instead of charity results in an approach to holistic legal aid which is personally tailored to each individual client, as our work is led by the needs, challenges and experiences of the people we work with. Additionally, providing individual holistic legal aid allows us to address the larger systemic issues our clients face, by carrying advocacy efforts based on their experience, while aiming to affect policy, urge governments and institutions to honour their commitments, and influence public awareness.

People seeking asylum in Greece, and in Europe at large, face a deeply disempowering system, in which those in search of safety are treated as helpless beneficiaries obligated to follow generalised rules. Especially considering this context, a focus on agency, individual experiences and human complexity is crucial in providing adequate and dignified humanitarian services. This International Day of Charity, we call to replace charity with empowerment. We urge all trying to make a societal impact to reach across, instead of reaching down.

Humanitarian work remains vital in light of Europe's violent border policies, and its inaccessible asylum system. Yet, in recent years, we have experienced a clampdown on the humanitarian sector in Europe, and especially in Greece.

As Greece neglects its responsibilities towards people seeking asylum, humanitarians have stepped in to provide essential services. In response, humanitarians are met with intimidation tactics and criminalisation through the misuse of the Greek legal system. Though the intimidation and bureaucratic harassment of humanitarian action is a disturbing development in and of itself, its consequences mark a larger problem: the criminalisation of humanitarian services threatens the rule of law.


Obstructing the monitoring of border crimes and prohibiting solidarity with people seeking asylum contributes to an increase in suffering and loss of life. We urge the Greek and European authorities to review the policies and practices that hinder the work of humanitarians.

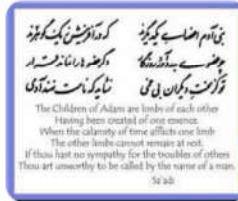

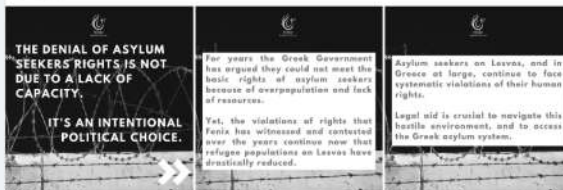

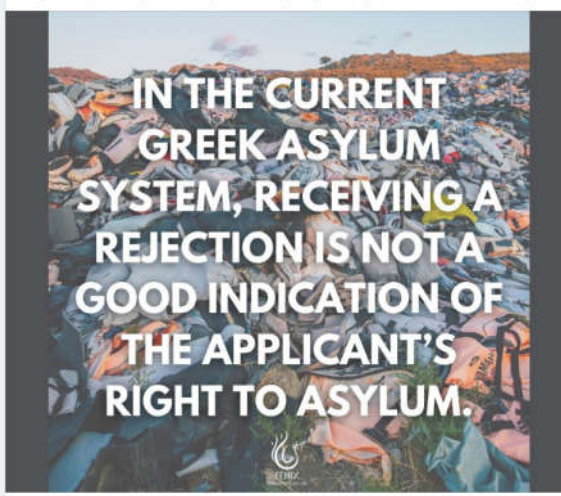

We came into contact with Z. during our outreach activities in Mavrovouni Camp. Z. was trafficked from Somalia to Turkey, where she was held captive. Z. managed to escape to Lesbos. Z.'s history of being trafficked makes her extremely vulnerable, and so Fenix took on her case.

Our team worked hard to prove Z. is unsafe in Turkey. This was a key component of Z.'s case: since Turkey is considered a safe third country for people from Somalia, it can be extremely difficult to access asylum in Greece. The work of our team paid off.

Z. now has refugee status here in Greece!

#EuropeDay was founded on values of unity and peace. Yet, the EU has been all but united with all fleeing in search of peace.

We witness a stark increase in the misuse of the legal system to prosecute asylum seekers and humanitarian workers. People that arrive by boat are brought to trial over charges for steering the dinghies they arrived on, while humanitarians are accused for crimes such as money laundering and espionage. Just last week, three Syrian nationals were sentenced to 439 years in prison for "aiding illegal entry".

At the same time, investigations by news outlets, non-governmental organisations and The European Anti-Fraud Office have demonstrated the involvement of Frontex and national European coast guards in illegal pushbacks.

While Frontex director Leggeri has recently handed in his resignation, it does not resolve the structural problems of Frontex and the Greek Coast Guard.

The current influx of people fleeing from Ukraine clearly demonstrates what many have been arguing: the problem is not the lack of capacity, but the lack of political will to receive people from other continents or that are not white or have a different religion.





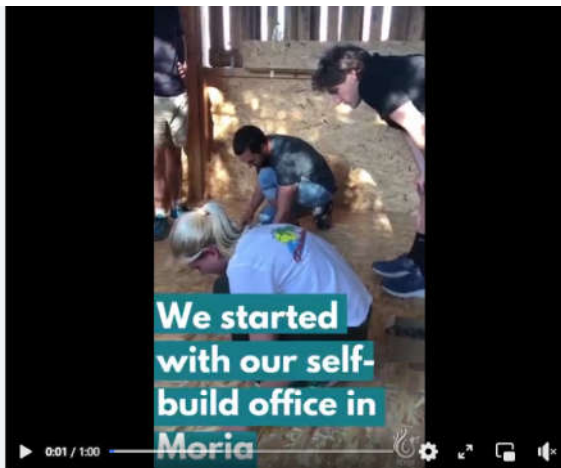

NEW OFFICE IN ATHENS!

We are so excited to share our new office in Athens!

Last October, we took the decision to open an office in Athens, to facilitate the work we have been doing on the mainland. We have been working hard to lift the geographical restrictions of our most vulnerable cases, so they can leave Lesbos and transfer to Athens.

Here, they can access services that are only available on the mainland. At present, 30% of our clients are on the mainland! With our new office and our staff there, we can give our clients the support they need, by removing the barriers that prevent them from having real and effective access to the right to seek asylum.

In Athens we already offer legal representation throughout all stages of the asylum process, psychological and medical case management. Our Athens team currently consists of two Greek lawyers, and a Greek psychologist. Soon, a protection officer will join this team, to create tailored and participatory action plans for each client in order to support their well-being, access services, and gather evidence that can strengthen their asylum claims.

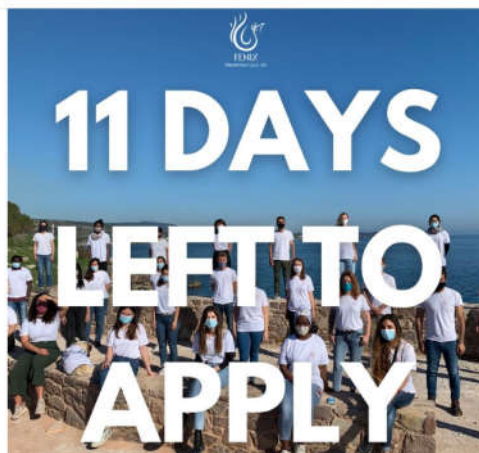

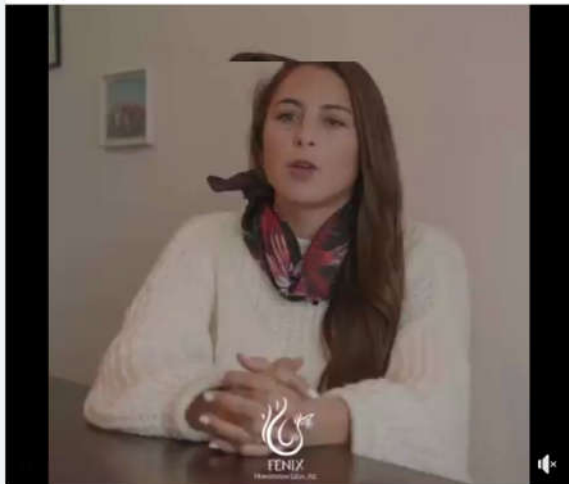

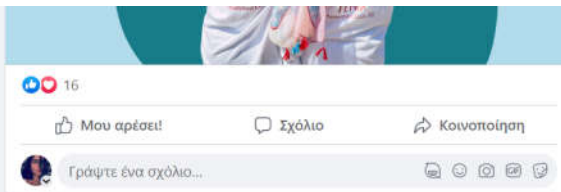
INTERNATIONAL WOMEN'S DAY 2022

2021 ANNUAL REPORT

While we have left 2021 behind us, we want to reflect on the impact of our work last year.

In 2021, asylum seekers were rushed through their asylum interviews 2 -5 days after they were allowed to leave quarantine. Our teams conducted outreach activities to newly arrived asylum seekers, to ensure their access to information about the procedure and to take on the most vulnerable as clients, in order to assist them in accessing their right to asylum.

Last year we have worked tirelessly to remove the barriers that prevent asylum seekers from having real and effective access to their fundamental rights, and this year we will continue that fight.

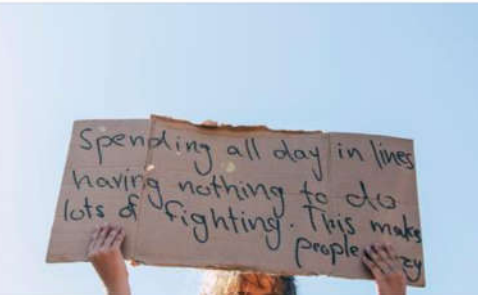

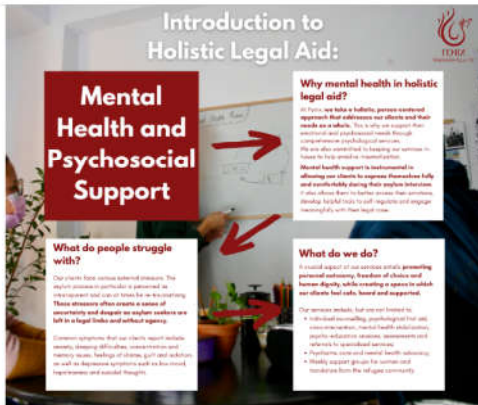

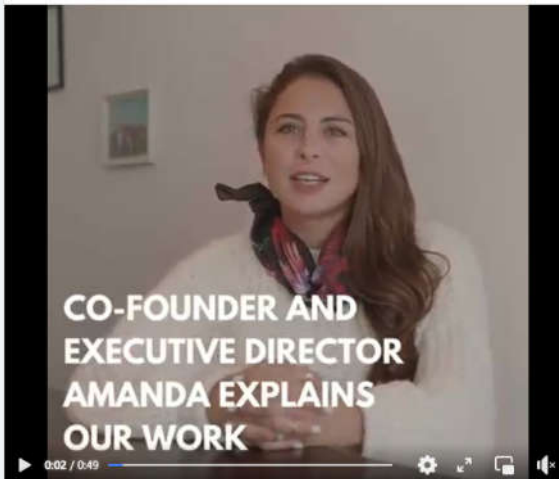

LET'S TALK ABOUT BARRIERS FACED BY LGBTQI+ ASYLUM SEEKERS 🏳️‍🌈

The process of claiming asylum entails sharing private, sensitive, and often traumatic experiences. This is especially true for LGBTQI+ asylum seekers, as seeking asylum on the grounds of SOGIESC relies on demonstrating that the applicant is at risk of persecution based on their actual or perceived orientation or identity, which is inherently personal. Since it is unlikely that much, if any, external evidence would be available to support a SOGIESC claim, there is an even greater emphasis on the applicant's testimony.

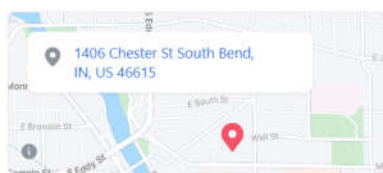
Based on the experiences of our clients with claims based on their sexual orientation or gender identity, we have identified several additional challenges that LGBTQI+ asylum seekers face.

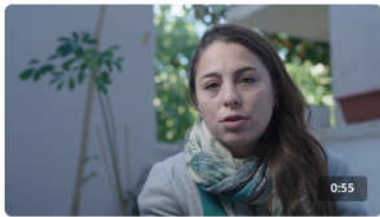

Even though there are less people living in Mavrovouni camp, the legal and protection situation for those who are on the island has shown little to no signs of improvement. This emphasises that, as we have continuously stated, rather than a problem of capacity there are structural and political issues which in turn create the punitive context for people who seek asylum.

Still, we can clearly witness the impact of our work in this often hopeless setting. This year, we have been able to continue expanding our capacity, as well as consistently support both asylum seekers, and local organisations.
