The whole system has been activated as a response to our emergency socio-legal intervention. But for us the most important thing happened. These mostly vulnerable children were 'seen' for first time.they had the space to be heard and loved. These children live alone unprotected unregistered without access to food and clean water in the jungle of Moria.



GLOBAL AWARD FOR CHILDREN'S GUARDIAN ANGELS IN GREECE

Three human rights defenders in Greece are among the ten awardees of Child 10 Foundation, for their unstoppable fight against child abuse, trafficking and sexual exploitation: Nantina Tsekeri, the Director of Defence for Children International Greece, Yonous Muhammadi, the President of Greek Forum of Refugees, and the head of the organization "The Home Project", Sofia Kouvelaki.

The award ceremony will take place on January 2020 in Malmo, Sweden, the base of Child 10, an organization that was established on 2014, aiming to support and strengthen vulnerable children. The awardees will each receive a fund of 10.000 dollars and will cooperate with each other, trying to get the best possible result regarding the urgent issue of protecting thousands of unaccompanied refugee

"The organization awards, every year, 10 exceptionally brave human beings, from all over the world, for their everyday struggle to protect the most vulnerable children, and prevent them from being maltreated and be taken advantage of, also being exposed to juvenile delinquency. We choose people that are committed in finding and implementing solutions that aim (to fill) the existing gaps in the field of protection and, through intervention and precaution measures, they fight against the danger of child exploitation", Jacob Flärdh, the General Secretary of Child 10 states. He also adds "Given the cross-boarder character of trafficking, the cooperation between the countries of passage and reception countries is crucial for child protection, as well as the decision making in a global level, that will focus on fighting this massive danger."

Defence for Children International Greece offers legal aid to children that were forced to flee their countries to go to Europe and they either live in really difficult environments, like refugee camps and detention centers, or they are forced to go through dangerous paths to go through the closed borders of EU." It is extremely important, at this specific period of time that so many unaccompanied children travel while being "invisible", that there is a strategic plan on behalf of actors that have the power and the means to accent this issue in a European level and also to be a better treatment for children that are victims of trafficking, during their immigration journey. We will cooperate with organizations from other Mediteranean Countries and it is so important for us to be a part of this attempt", Nantina Tsekeri the Founder&Director of Defence for Children Int. Greece states.


The issue of child protection is the highest priority for the President of the Greek Forum of Refugees, Yonous Muhammadi, since he has experienced himself the conditions they face. "In 2001, when I first came in Greece, I had two choices, either sleep in the park or in police detention centers, with so many other children. At this point, so many children are practically invisible, and the number is increasing in really worrying levels, as worrying as the dangers they face: sexual exploitation, trafficking, drug dealing. For this reason, this award gives me the strength to keep trying, but it doesn't make me that happy, since these problems still exist", Yonous Muhammadi, highlights.


A drawing by a child living in Moria refugee camp in Lesbos, Greece. The child is one of the many minors who attempted suicide in Moria.




Happy #WorldChildrensday!

Earlier today, the Coordinator of our Helpdesk, Iris Pappa, was at Velos Youth Center informing unaccompanied homeless children about their rights, the asylum legal procedures and any durable legal option available to them. Children, on most occasions, are not aware of their rights, such as their right to legal support, their right to education, their right to have a safe shelter and their right to family reunification. As a result, they run the risk to stay invisible and exposed to different forms of exploitation!

Defence for Children International -Greece promotes the due implementation of Children's Right to Information (Article 17 of the CRC) by providing information sessions to refugee children.

We are always next to every child on the move ,every child that lives on the street, every child in need.









Participation, best interests principle and crisis narrative are some of the topics that were also touched upon!











Διαβάστε το δελτίο τύπου της Defence for Children International Greece για το νέο νομοσχέδιο του Υπουργείου Προστασίας του Πολίτη σχετικά με το άσυλο, την υποδοχή και την κράτηση αιτούντων διεθνή προστασία:

"Η Defence for Children International Greece, κατ" αρχάς, θεωρεί ότι η πολύ μικρή διάρκεια διαβούλευσης ενός νομοσχεδίου με πολλά άρθρα και εκτεταμένες αλλαγές, ουσιαστικά αποτρέπει το νομικό κόσμο και τις οργανιώσεις ανθρωπίνων δικαιωμάτων να το διαβάσουν και να το σχολιάσουν σοβαρά και επαρκώς.

Επί της ουσίας, το νομοσχέδιο προσανατολίζει όλες τις διαδικασίες ασύλου και υποδοχής και φιλοξενίας στις επιστροφές αιτούντων άσυλο, είτε στην Τουρκία είτε στις χώρες καταγωγής τους, θέτοντας πολλά, συχνά ανυπέρβλητα διαδικαστικά εμπόδια στην άσκηση των δικαιωμάτων τους για πρόσβαση στο άσυλο, στην κατάλληλη υποδοχή και φιλοξενία.

Αναφορικά με τους ανηλίκους και, ενώ διακηρυκτικά, η αρχή του βέλτιστου συμφέροντος του παιδιού πρέπει να τίθεται στην καρδιά των ως άνω διαδικασιών, η εν λόγω αρχή περιφρονείται στο υπό ψήφιση προτεινόμενο νομοσχέδιο.

Ενδεικτικά αναφέρονται τα ακόλουθα σημεία του νέου Νόμου:

Τα παιδιά χωρίς χαρτιά δε θα δύναται να εγγράφονται πλέον στο σχολείο, καθώς η σχετική πρόβλεψη του ισχύοντος νόμου αφαιρείται στο προτεινόμενο άρθρο 51, παράγραφος 1 του νέου Νόμου. Με τη νέα αυτή ρύθμιση, ένας μεγάλος αριθμός παιδιών θα μείνει αποκλεισμένος από την εκπαίδευση, κατά παράβαση της Σύμβασης για τα Δικαιώματα του Παιδιού, που έχει ενσωματωθεί στο ελληνικό δίκαιο και υπέρτερη έναντι κάθε εσωτερικού νόμου.

Επιπλέον, η Defence for Children International Greece, εκφράζει την έντονη ανησυχία της αναφορικά με την παντελή παράλειψη λήψης ουσιαστικών μέτρων για την άρση του απαραδέκτου καθεστώτος της κράτησης ανηλίκων (υπό τον ευφημισμό της "προστατευτικής φύλαξης"), τη στιγμή που ο αριθμός των ασυνόδευτων ανήλικων παιδιών που κρατείται στις φυλακές επ' αόριστω (αντί να φιλοξενείται σε κατάλληλες δομές) αυξήθηκε σημαντικά κατά τους τρεις τελευταίους μήνες. Συγκεκριμένα, στις 30-09-2019 οι ανήλικοι υπό "προστατευτική φύλαξη" ήταν 238 έναντι 139 στις 30-06-2019. Ανήλικοι συνεχίζουν να κρατούνται υπό απαράδεκτες συνθήκες σε Αστυνομικά Κρατητήρια και Φυλακές ενώ οι λεγόμενες "ασφαλείς ζώνες" στα κέντρα υποδοχής στα νησιά του ανατολικού Αιγαίου δεν πληρούν ούτε τις ελάχιστες προδιαγραφές για την ασφάλειά τους και την αξισπρεπή διαβίωσή τους.

Ιδιαίτερα ανησυχητικές είναι και οι προτεινόμενες ρυθμίσεις για τις ευάλωτες κατηγορίες προσώπων. Συγκεκριμένα, τα ευάλωτα πρόσωπα, με βάση την προτεινόμενη διάταξη, θα αποκλείονται από ταχείες διαδικασίες των συνοριακών διαδικασιών, μόνο εφ' όσον δεν είναι δυνατή η παροχή υποστήριξης στο πλαίσιο αυτών των διαδικασιών, ενώ με βάση το ισχύον καθεστώς αποκλείονται σε κάθε περίπτωση από τις ταχύρρυθμες διαδικασίες. Οι κατηγορίες των ευάλωτων ανθρώπων είναι λιγότερες από τον προηγούμενο νόμο. Οι δε ταχύρρυθμες προθεσμίες καθίστανται ανησυχητικά σύντομες αφ' ενός περιορίζοντας τα δικαιώματα των αιτούντων (όπως στην προετοιμασία και στην παράσταση με δικηγόρο ή σύμβουλο) και, αφετέρου, καθιστώντας τη διοίκηση αδύνατη να ανταπεξέλθει καθώς δε διαθέτει ούτε το προσωπικό ούτε τις σχετικές υποδομές. Περαιτέρω, δεν ορίζονται ποιές θα έιναι οι διαδικαστικές εγγυήσεις, γεγονός επισφαλές για την ασφάλεια του δικαίου και τη σαφήνεια που απαιτείται ώστε να μπορέσουν να εφαρμοστούν οι σχετικές διατάξεις επαρκώς από τη Διοικηση. Τέλος, δεν προβλέπεται ποιός και με ποιά κριτήρια θα αποφασίζει εάν θα εξαιρούνται ή όχι από την ταχεία διαδικασία των νησιών οι ευάλωτοι αιτούντες. Σε κάθε περίπτωση, λόγω της αυστηροποίησης της διαδικο υπάργουν πιθανότητες να αποβάλλονται από τις διαδικασίες διεθνούς προστασίας ευάλωτα πρόσωπα.

Τέλος, η Defence for Children International Greece επισημαίνει τα διαδικαστικά εμπόδια που τιθενται στο νομοσχέδιο για την άσκηση της προσφυγής κατά της πρωτοβάθιας απόφασης. Ο αιτών άσυλο θα υποχρεούται να υποβάλει αίτημα για να λάβει την πλήρη απόφαση απόρριψης του αιτήματός του σε πρώτο βαθμό και επιπλέον να παραθέτει αιτιολογημένους λόγους στο έγγραφο της προσφυγής του, χωρίς ωστόσο να του εξασφαλίζεται η πρόσβαση σε δωρεάν νομική βοήθεια που προβλέπει το κοινοτικό δίκαιο.

Τα ανωτέρω παραβιάζουν το δικαίωμα των αιτούντων διεθνή προστασία για πραγματική και αποτελεσματική προσφυγή.


Ειπλέον, καθίστανται οιωνεί δικαστήρια οι δευτεροβάθμιες Επιτροπές Προσφυγών με τη συμμετοχή τριών δικαστών ή Μονομελής έτσι ώστε να υφίσταται ζήτημα συμβατότητας της ρύθμισης με το Σύνταγμα που απαγορεύει τη συμμετοχή δικαστών στη διοίκηση πλην συγκεκριμένων εξαιρέσεων.

Η Defence for Children International Greece κρίνει πως τα ως άνω σημεία εκθέτουν τα παιδιά αιτούντες άσυλο σε επισφαλείς συνθήκες που δύναται να δώσουν έρισμα για συστημική παραβίαση των θεμελιωδών δικαιωμάτων τους. Παράλληλα, υπογραμμίζεται ότι το εν λόγω νομοσχέδιο "κλείνει τα μάτια" τόσο στις ανάγκες των παιδιών αυτών όσο και της ελληνικής κοινωνίας για ομαλή συνύπαρξη με αμοιβαίο σεβασμό στην αξιοπρεπή διαβίωση όλων. Αντιθέτως, ελλοχεύει ο κίνδυνος να δημιουργηθούν 'αόρατα παιδιά' αποκλεισμένα και κοινωνίες δύο ταχυτήτων.

Σε αναμονή των αποτελεσμάτων της 'διαβούλευσης' του εν λόγω Νόμου και την επίδειξη αντανακλαστικών ανθρωπιάς και δικαιοσύνης από την πλευρά του ελληνικού νομοθετικού οργάνου."



"Our Director, Ms Nantina Tsekeri talked today in the Lesvos news stonisi.gr about the crucial situation of the unaccompanied children in Moria Camp.

She referred extensively to the unaccompanied minors that are being exposed to a great number of dangers on a daily basis. They are the silent victims of the lack of an effective child protection system in place'.

There are 1013 unaccompanied minors living in Moria Camp right now. The escalation is rapid. Only 300 of them reside inside the sections. The rest of the children sleep rough on the ground in a big tent. The First Reception staff members of the Camp are doing their best to protect the children but that is not enough. After 9 o' clock, there is no protection provided at all, because of the lack of staffing. During the night, children run into the woods in order to hide from the adults that

This is the Europe of 2019, Nantina continued.

"All I want is a family to love me", a minor told Nantina. 'It is very important for the children to have the opportunity to express their voice. This campaign was built on the idea of giving the children the space to express themselves and directly convey their message to the European leaders. They want to let them know that they are exposed to serious dangers, that they are dirty, hungry and scared. They want to tell them that they need to be rescued out of this 'open Guantanamo'.'

The legal framework regarding the cases of unaccompanied minors dictates that the children should be residing in the Moria Camp for a very limited time just for identification and then to be transported to the mainland, to a safe shelter. The main problem is that there are not enough shelters for all the children in the country. Some of the minors do not even have access to the asylum procedure. They are living in a state of uncertainty. Furthermore, everything takes a very long time, the registration, the family reunification procedures, even the transfer of the children from Moria to other shelters. All the procedures, for this particular group of population, should be sped up. This is, by far, the most challenging and crucial problem. This idea of speeding up procedures is used widely lately, in a political level. However, the task of speeding up the proceedings, should be orchestrated very carefully, otherwise might have a 'boomerang effect'. Every act should be processed, taking into consideration, the best interest of the child.'

The vast majority of children have family members in other European countries. But, even in the cases of family reunification, under the Dublin III regulation, there are still problems and great delays occurring. They can stay up to 8 months trapped in Moria, because of the delays. Family reunifications must become swifter, always taking into consideration the best interest of the child.

Nantina, also referred to the imminent need of a foster care system. 'Unaccompanied children deserve a family and have the right to live in an environment that supports their growth and development, idea well esrablished in the Convention of the Rights of the Child (CRC). DCI Greece highly supports the idea of a European foster system.'

Referring to children's health, she highlighted their right to healthcare, including mental healthcare. It is very important to allow children to live a normal life. Despite the best intentions and efforts of the professionals working in Moria, that cannot be possible for a child that resides in a Camp. All children are already deeply traumatized by all their experiences encountered in their country of origin as well as along their smuggling journey. A great number of them are victims of trafficking. They reach Greece, with the dream that they will be protected. This is not the case though. The horrible living conditions inside the Moria Camp further deepen their trauma. The first case of 'resignation syndrome' was documented a few days ago. 9 year old Aysha has stayed in a state of withdrawal for two weeks, she does not move, speak, or open her eyes.

Nantina also commented on the recent tragic incident of the murder and serious injury of unaccompanied minors, by another unaccompanied minor within the 'safe

cone of mora camp, an income use, unequivocary morace are devastantly effects of abandoning unaccompanied minors in inhumane living conditions. All the above, are factors that push the children into delinquency."

Answering the journalist's question about the country of origin of children, she answered that, most unaccompanied children in Moria camp come from Afghanistan. She also commented on the recent political statements, regarding the 'refugee profile' of migrants and addressed these political claims that present only the Syrian population to meet the refugee criteria. As she mentioned, Afghanistan, last week, was declared as the most dangerous country in the world. 'That proves that, the children that arrive in Moria Camp are indeed, in need of international protection. Of course, every case is different and should be assessed individually, during the asylum interview.'

Furthermore, equal distribution of the refugee population in all the EU States, especially children, is very crucial. This was proven to be possible in the past. She referred to the example of the global distribution of refugee population, after the war in Vietnam, where mass numbers of refugees were distributed all around the world.

Nantina calls everyone to join the 'Can you hear me' campaign, by adding the hashtag #dont_leavethekidsalone. We all need to become the voice of all the Moria Children, so the European leaders will listen! It is a very crucial moment for the rights of unaccompanied refugee children. We have the obligation to give them the tools that will help them support themselves."

More than 800 unaccompanied minors live in the, already overcrowded, Moria Camp, exposed to hazardous conditions for their health and overall protection. During the last month, there has been documented a systematic increase in the number of unaccompanied minors being hosted in Moria Camp.In particular, unaccompanied minors, due to the lack of adequate space and overcrowding, are forced to sleep on the floor in outrageous conditions. They are unable to access medical and psychosocial care, while being exposed to serious risks to their physical and mental health.

The recent tragic incident of the murder and serious injury of unaccompanied minors by another unaccompanied minor within the 'safe zone' of Moria Camp

unequivocally indicates the devastating effects of abandoning unaccompanied minors in inhumane living conditions. The systematic failure of meeting the peculiar needs of these children coupled with their exposition to the existing living conditions in the various Sections of Moria Camp, aggravates their already unstable psychological state and heightens the risk of triggering additional acts of despair, in addition, due to the lack of staff capacity at the KEELPNO services, unaccompanied minors only get pre-registered without being able to proceed with their full registration at the Asylum Office. This condition has an adverse effect on the evolution of both their placement in appropriate shelters in the mainland, as well as, on their family reunification case under Dublin III Regulation, given the fact that most EU states accept family reunification requests within a three month deadline since the pre-registration date.

It is evident that the existing situation violates the national, EU and international legal framework which recognizes that children on the move have the absolute right to enjoy their childhood in a secure, caring and protective environment. Especially, regarding unaccompanied minors on the move, EU Member States have recognized their extreme vulnerability and have taken responsibility to protect them in practice, by ensuring that their vulnerability does not deprive them of the dignified life they deserve.

However, in reality, children are the victims of the European immigration policies that while being implemented have given rise to such horrible living conditions on the Greek islands. In particular, the EU-Turkey deal has forced thousands of people, among them hundreds of unaccompanied minors, to be trapped in the unsafe environment of Moria Camp.


We urge EU Member States to take immediate action to 'rescue' the unaccompanied minors from the Moria Camp, by speeding up the family reunification procedures, relocating them to other EU States and adopting general measures aiming at the equal distribution of the European responsibility towards the people in need of international protection.

In the meantime, we urge the Greek State to prioritize the transfer of unaccompanied children to appropriate shelters in the mainland while simultaneously proceeding with the creation of new ones.

At the same time, we call for the direct staffing and reinforcement of the public health and social support services in Lesvos and mainland.


Possible delays and inadequate response to the current critical situation run the risk to coerce more children to transgressive behaviors and serious risks of their life.

Afghan Hazara family experiencing extreme violence in Greece and seeking for justice. It is important that their voice will be heard and the phenomenon will be tackled.


