A week ago, we were informed about the case of Amira, a 13 year old girl from Syria that is alone in Athens. We immediately met the girl and started the case management. We had to be quick and efficient, since the holidays were approaching and the girl would be left unprotected in an apartment with people she doesn't know, exposed to countless dangers.

We informed all competent authorities regarding the severity of this situation and, within 2 hours, a safe shelter was found!

However, there was another obstacle we had to overcome, the medical exams required for the transfer had to be completed within 3 days. We managed to coordinate everything and today we have all the results in our hands.

🎉 The little girl just got transferred to the shelter! She is finally safe!

Now, we are working on her family reunification with her relative in the Netherlands. The dna test is already completed and we are hopeful she will soon be in a loving family.

We will stay by her side and keep supporting her, until she is happy again!

DCI is offering case management and complete child protection services to alone children like Amira. Support us so we can keep offering our services to the most vulnerable of children.

This is the reality in Moria2.

Despite the 400 unaccompanied children that were transferred to the mainland, after the catastrophic fire in Moria camp, hundreds of children with their families, including little babies, as well as alleged minors, are still trapped in an even worse environment.

The new camp in Lesvos is no better than Moria.

Tens of thousands of refugees, including very young children, spend their days exposed to the harsh weather of Lesvos, trying to survive. It's our duty to never forget them and try to stand by their side.

DCI Greece urges the Greek State as well as all other European States to take immediate action for the relocation of these families and the alleged minors.

Exciting news!!! Shelter is found for our K, the young boy who was homeless, stabbed and chased by smugglers, as we informed you in previous post (follows after this post) 🌱

After activating the official child protection system, and working closely with the official authorities of accommodation, the Juvenile prosecutor and the Ombudsman of Children's Rights, little K. will soon get transferred to a safe shelter. After everything that has happened to him, he will finally find peace, safety, and a chance to heal with wounds, physical and emotional, in an appropriate environment.

Right now, we have to make sure we organise and book all the hospital appointments, so he can undertake all the medical tests required, as soon as possible.

We are overwhelmed with happiness for his new beginning and we cannot wait to see what the future holds for him. Good luck, our dear K!

15 year old boy from Afghanistan, trusted a smuggler. He handed him all his money, so he can have a place to stay and to help him reach Germany and be reunited with his sister. The smuggler deceived him and stole his money. He even stabbed the boy multiple times, on his body and his head. The child was transferred to the hospital, where he fell in a coma for days. He has now recovered, but his wounds, both physical and mental, are very deep and painful. Right now, he is homeless, living rough on the streets and squares of Athens.

DCI Greece is currently doing all the case management with all competent actors and authorities, to guarantee the safety of the child, as quickly and as effectively as possible.

This boy's story, along with hundreds of similar ones, proves the absence of an effective protection system for children on the move. Children receive no information when entering Greece, something that makes them an easy prey for people wishing to exploit them, while at the same time there is no guardianship programme to protect them, along the asylum process.

Covid 19 has been having a tremendous impact on the lives of homeless, unaccompanied children in Athens. Their vulnerability becomes even more extreme.

More and more homeless children are forced to live in shared apartments with adults. These children are forced to cook, do all the chores and everything else asked by the adults. Sexual and economical exploitation becomes an everyday phenomenon.

Since the beginning of the outbreak, DCI Greece has been in contact with vulnerable

children, either directly through our Helpdesk, or through our online group into sessions. We have been conducting risk identification and doing all the necessary steps so these children can be transferred to a safe shelter.

As a result, over than 30 children were finally led to safety, after our Helpdesk actions, since the beginning of the outbreak.

Today, at the EU Anti- trafficking day, joint call to end child trafficking!

The spread of the COVID-19 virus has disproportionately affected marginalised groups including migrants, not only resulting in a rise in child trafficking and exploitation but also further highlighting the risks and vulnerabilities faced by these children.

Together with [Child10](#) and the other 2020 Awarded Members, we have opened a much-needed dialogue on joint cross-border challenges and solutions to address trafficking of children along the migration routes towards Europe.

Although there are many gaps in the official child protection systems, we have identified two specific areas where we continue to see the consequences of inadequate protective mechanisms for children: the identification of trafficking victims and their access to assistance and protection.

In our joint call for action, we are asking policy makers to focus on implementing concrete recommendations, as the need for action is now more important than ever.

'She was no older than 8 years old. I saw her desperate efforts to find a discent toilet to enter. She was opening the one door of the few chemical toilets in the camp, after another. The dignity she has reserved for herself didn't allow her to enter any of them in the end. She run back to her tent almost crying.

Moria2 is well in place with the stamp of EU and International Actors. The phenomenon of "Moria" was apparently never meant to stop. It has just been transferred some kilometres closer to the water. Together with this, the childhood of these children has been postponed to infinite time', said our Director Nantina Tsekeri during her mission to Moria2 today.

The argument proposed, that this situation is temporary, does not suffice to justify the continuous HARM caused to these children every single day by EU States' actions

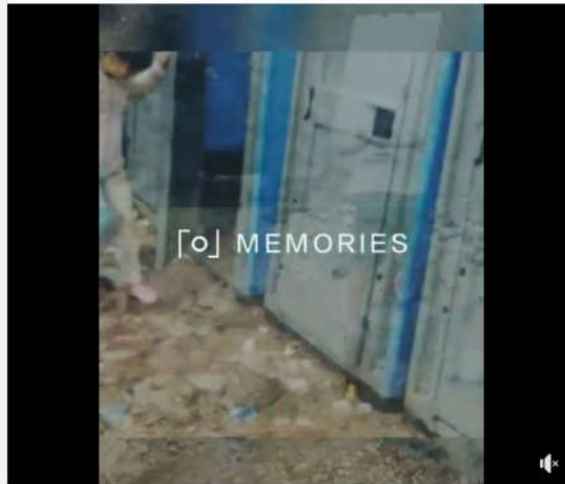
and omissions.

The smuggler deceived him and stole his money. He even stabbed the boy multiple times, on his body and his head. The child was transferred to the hospital, where he fell in a coma for days. He has now recovered, but his wounds, both physical and mental, are very deep and painful. Right now, he is homeless, living rough on the streets and squares of Athens.

DCI Greece is currently doing all the case management with all competent actors and authorities, to guarantee the safety of the child, as quickly and as effectively as possible.

This boy's story, along with hundreds of similar ones, proves the absence of an effective protection system for children on the move. Children receive no information when entering Greece, something that makes them an easy prey for people wishing to exploit them, while at the same time there is no guardianship programme to protect them, along the asylum process.

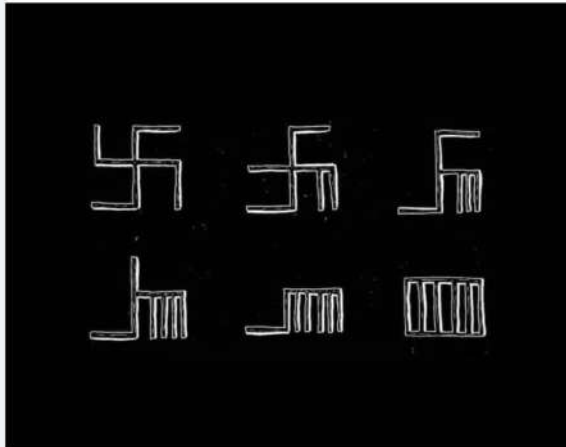

Yesterday, Ylva Johansson presented the proposal for a new migration pact for EU Member States. The proposal will not help to resolve the situation in Greece, and it will, if adopted, still be up to each country to voluntarily stand up for human rights. Today in Sweden's largest newspaper the three Greek Child10 Awardees from Greek Forum of Refugees, The HOME Project and Defence for Children International Greece together with us are calling out the Swedish government to hide behind false and poorly constructed excuses to not take part in the relocation of children from Greece.

I wish only fire and nature were angry with the asylum seekers! Anyway, the anger of the fire is temporary and controllable, but what should we asylum seekers and displaced people do with the anger of the Greek people?

It has been a year since I was transferred to the mainland with my two children.

My daughter grew up in Camp Moriah.

After moving to the mainland, he was happy to continue his education, but unfortunately, they said: because you are old, you can no longer enroll in school. He was very upset. It was difficult for him to make a living.

Fifteen days later, social workers informed the organization that he had left home and went to Athens from the island of Crete, and the organization unfortunately cut off 150 euros without any consideration.

And social workers say: Your daughter is no longer covered by UN and has no right to return to you.

My daughter was undecided and left alone in Athens, and with the onset of coronation and quarantine, she became unemployed.

For some reason, it was not time for entry.

During this period, Andy has been suffering from a crisis and mental problems. He is unemployed and desperate in Athens. I knocked on every door and no one answered.

My 10-year-old son and I were accepted after a year, and as soon as I received a positive response from social workers, I was warned that I had to leave home.

It means acceptance in Greece, homogeneity, homelessness and homelessness !!

Desperate and helpless, I joined several Facebook groups related to real estate and rental advertising.

I wrote there: "I need a small apartment with my two children. We can pay a rent of 200 Euros a month."

After a while, I received insulting messages and ugly words from some members of the group, etc.

Some wrote:

"We do not allow foreigners to leave our country."

Some wished you were all drowned in the sea!

There are some writing skills that are not worth mentioning.

People do not give home to "foreign nationals" on the island of Crete!

And this anger and hatred of the people is much more worrying than the anger of the fire and the roaring waves of the Aegean Sea and its dangers!

Because the only hope and strength of the heart of the displaced is the love, compassion and kindness of the people of European countries.

We asylum seekers do not hope for the false words of the world's ruling politicians, nor for the support of international human rights organizations, because they have all lost their color and glaze for us and their expiration date has expired!

But if the civilized people, with the culture of ancient Greece and Europe, find a negative and hateful attitude towards the asylum seekers and narrow the field for them, the situation of the asylum seekers will become very bad and worrying.

I personally believe that the EU agreement with Turkey and Greece to restrain asylum seekers from receiving money in this "current way" is a shameful and inhumane agreement, and I consider the dire consequences to be very dangerous.

I believe that high-ranking Greek officials have made a big mistake.

I imagine this "current way" of asylum seekers for both Greece and for asylum seekers accepted in Greece in the not too distant and very distant future!

I declare danger for Greece, despite this large number of helpless and unemployed asylum seekers with mental health problems. Man, who faces poverty and economic problems, etc., becomes a dangerous creature!

I do not know whether the EU money has taken the understanding from the Greek authorities or they have neglected themselves that they do not understand this danger ?!

It seems that in the not too distant future, Greece will face many crises and problems by these hungry and unemployed asylum seekers.

I warn the Greek authorities to open their eyes and ears as soon as possible, to give a basic thought to their country.

Otherwise, in the very near future, they will witness all kinds of social anomalies such as theft, violence and conflict, the phenomenon of begging, sleeping cartons, numerous fires in forests and other places, and so on !!

I also told the European Union in 2015 that when you saw the body of

a Syrian child, you were very emotional, you opened the doors of Europe to asylum seekers, but in the not too distant future, you will regret it.
And then with the death of no child or human, your feelings will not be aroused. And that day came less than two years later, and now, five years later, it has reached its peak.
What happened that the compassionate, kind and emotional leaders of the European Union, after a short time, became the leaders of the heart, unkind and unfeeling ?!
Why other corpses of children drowned in the Aegean Sea and the dismembered corpses of children in Camp Moriah and undecided asylum seekers in Turkey and Greece, children deprived of education
And their other inalienable rights do not arouse your feelings ?!
Where was that kindness and humanity of your 2015 ?!
Why do you call the asylum seekers hostile enemies and say: the European Union does not leave Greece alone to prevent the entry of these "invaders" ?!
What happened when Yahoo gave asylum seekers the title of attackers ?!
Damn the systematic politics that parents do not have !!!

Over the past days devastating fires burnt down the Moria Registration and Identification Center and surrounding areas, the EU Hotspot on the Greek island Lesvos. The fires have left thousands of vulnerable individuals homeless and traumatised, among them unaccompanied children.

While we are shocked and saddened at these developments, they come as no surprise. Lesvos and the other EU Hotspots on the Aegean islands have reached breaking point long ago. Following the EU's decision earlier this morning to fund the transfer of the 400 unaccompanied children of Moria to the mainland of Greece, we got in touch with the EU Commissioner, Ylva Johansson, aiming to express our concerns that:

- amongst the 400, there are many unaccompanied children who have already received a positive decision to be reunited with their family members in other European countries. For unjustified reasons, the arrangement of their transfer to the destination country has not taken place yet. There are children who received the positive decision 5 months ago and, despite that, they have been still waiting to travel to their families.
- We find it crucial that these children will be transferred to the destination country ASAP without further delays.
- there are much more children amongst the 400 identified, that have a pending family reunification case for months. It would be very significant, if European States could be reminded to speed up the process and apply the best interests of the child principle effectively along the process. We have documented many unlawful rejections of family reunification claims that we could bring to Commission's attention upon request.
- we asked the kind contribution of the Commissioner in calling the Greek State on its responsibility to transfer the Moria unaccompanied children to appropriate for their age shelters and provide them with direct access to information and legal assistance. Protective custody could not be seen as a suggested alternative.

Finally, we underlined that we find it crucial that any decision taken as a response to the emergency situation should not normalize further compromises to what is ought to them from an ethical and legal perspective.

'Hi, I don't have much time to speak to you. They might come back. I stay in a house with 7 adult men strangers to me. I need your help. I am afraid.', his first words when called us at our Helpdesk first time one month ago.

M is one of the thousands of unaccompanied unregistered children on the move, that Covid-19 lockdown forced them to seek for a place to sleep in overcrowded apartments, shared with older men, in Athens.

An individually tailored emergency plan of support was instantly activated from our Helpdesk Team for him including legal actions, risk identification, empowerment support and communication with the competent Authorities. Little M had to become safe and visible to the Greek State.

Today, M is being transferred to a safe shelter. Tonight M will sleep protected.

However, his story reflects a broken child protection system. Even after receiving the positive news of finding shelter, M was again left alone. There was no one there to guide him and help him navigate, in a language foreign to him, through a series of medical tests and administrative processes in order to be 'admitted' at his new place.

Our Helpdesk had to cover this gap too.

Gurdianship is an absolute right of all children. More delays with the implementation of the relevant Law and the due hand over to the Greek State might cause the loss of many childhoods.

For these children, leaving Moria Camp is a survival issue. It is more crucial than ever that Europe hears their voice and provides them with the ticket out of the hell of Moria.

Our Themida legal team, working on the family reunification applications of children

living inside and outside Moria Refugee Camp, in collaboration with @betterdays, has received 2 more positive decisions the last weeks. 24 in total!

However, the majority of these children that received a positive answer are still stuck in the toxic environment of Moria, exposed to countless risks, instead of being in the safe arms of their families in other EU countries.

Right now, due to COVID 19, there are extreme delays to the issue of the tickets. At the same time, 44 more cases are still pending and waiting to be reviewed by the authorities of the Member States.

Such long delays are contrary to children's best interest and interfere with their right to family life and unity, while clearly deteriorate further their mental health, as they pose them on a standby mode for a long time.

Children residing inside or outside Moria Refugee Camp experience an additional wave of persecutory harm, defined by serious breaches of their right to psychological and emotional development, right to health, right to special protection from all forms of violence. For this reason, it is important Member States to take immediate action and speed up the whole procedure of family reunification and especially children's transfer, where the reunification has been judged to be in the best interest of the child and the family link between the child and the relative has been established.

'I cant believe I am safe now! I have asylum! All this time I was living with the fear of deportation back in Afghanistan.'

Our 17 year old A. , we have been working with for more than a year, granted today his asylum. Greece recognized him as a refugee and provided him with

international protection.

A. was tortured in his home country and was deprived of any sense of dignity safety and security. His journey to Greece was difficult and dangerous considering the risks he was exposed to. When A. came to our office one year ago, he was feeling lost and hopeless. He was scared, homeless, living on the streets and was totally unaware about his rights and asylum procedures. He was even detained for some weeks under the scheme of protective custody and due to the lack of shelters.

One year later and A. is living in a shelter, he is going to school while in the coming months will receive the coveted passport. However, due to the lack of opportunities for integration of recognized refugees, this protection may remain only in paper. Recognized refugees are expected to leave assistance only 1 month after receiving their asylum or become 18, the moment Greece has not managed yet to create a successful programme for their smooth integration into society. As a result, they can be exposed in serious risks, like homelessness, unemployment and exploitation.

The story: The boy called our Helpdesk in despair, informing us that he was in prison for months. He was transferred from police station to police station, without even understanding what he did wrong. We explained the procedures and took all necessary legal steps required for his release informing at the same time the competent authorities. Finally, a safe and age appropriate shelter was granted for him.
Despite the great efforts from the official authorities of accommodation, there are thousands of unaccompanied, homeless children that get arrested and placed under protective custody, due to the lack of shelters.

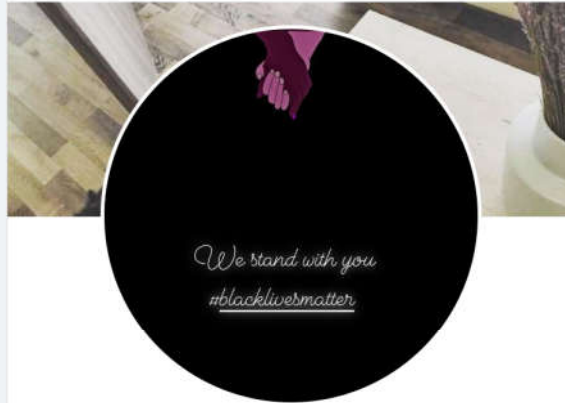

So happy to announce that shelter was found for J., an unaccompanied minor that was living rough on the streets for several weeks, while afterwards, due to COVID 19 and the quarantine, he was forced to live in a shared apartment with adults. We detected the child through the online sessions we run and immediately took all the necessary steps for his transfer to a safe facility.

The story:

During one of our online info sessions back in April the 16 year old boy, told us: 'Due to the lockdown, I cannot go outside and visit the youth centers like before. I have to stay in a tiny apartment with many people 24/7. I am afraid.' In fact, during the video chat the DCI team had with the minor, an adult approached him to check who he is talking to. The boy seemed terrified. When the info session ended, we had a private call with him. He informed us that he is staying with 15 adults he doesn't know and has never seen before. He confessed that he is scared every night and that he cannot sleep. We immediately informed, by submitting legal reports, the official authorities of accommodation about the situation, as well as the Juvenile Prosecutor and the Ombudsman that the child is in great risk of exploitation.

Of course, despite the great news and the efforts from the authorities, there are still thousands of homeless children, at risk of exploitation.

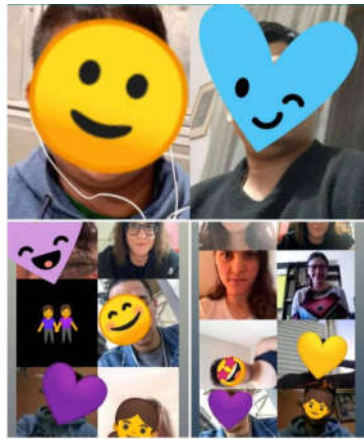

A positive result was achieved after some day and a shelter in the mainland was granted. However, due to COVID 19 the transfer is still pending. DCI Greece is currently putting pressure to the authorities so as to guarantee the transfer of the child.

There are currently hundreds of unaccompanied vulnerable children in Moria Camp. Even though some of them have the chance to escape this hell, covid-19 has delayed every single progress that could be made to improve the life of the children.

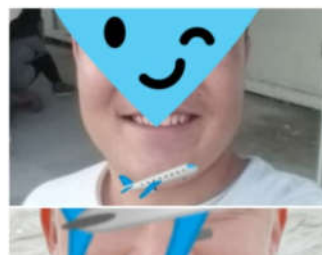

DCI GREECE and 19 other NGOs and Lawyers call for voting against provisions that jeopardize fundamental rights of applicants for international protection

Athens, 7 May 2020 - Following a joint memorandum sent to the Minister of Immigration and Asylum and Parliament on 5 May, twenty NGOs and lawyers highlight that provisions of the new asylum bill further jeopardize the rights of applicants of international protection and also the guarantees of the asylum procedure as a whole.

They note that the constant changes in the law in a short period of time - without even taking into consideration the multiple issues arising from the implementation of the existing asylum legislation - are creating further delays, while there are provisions that do not reflect the reality in the field, which may lead to violations of national and EU law.

Among others, the new measures:

- * maintain the examination of asylum applications of unaccompanied children with the fast-track procedures (Law 4636/2019), which is not in their best interest, a provision that needs to be amended,

- * abolish the priority of examining asylum claims of vulnerable asylum seekers (unaccompanied children, victims of torture, violence, etc.), risking their exclusion from the more favorable treatment provided by EU law for their protection,

- * further reduce deadlines, particularly for appeals,

- * abolish the possibility of the Independent Appeals Committees to refer cases to the Ministry of Immigration and Asylum for the issuance of residence permits for humanitarian reasons, endangering the fundamental rights of people who, although not entitled of international protection, have the right to reside in Greece, such as unaccompanied children and people with serious health problems,

- * further generalize the use of administrative detention, making this method the norm, against the provision of EU law, where it is an exception.

Steps such as the establishment of the new Special Secretariat for the Protection of Unaccompanied Children can work positively, as long as the guardianship institution is launched and steps are taken to end the detention/"protective custody" of unaccompanied children. The timely staffing of the new Secretariat with properly trained staff and coordination with the other competent authorities, in particular the National Centre of Social Solidarity, should be ensured.

Many of the provisions of the bill will have severe consequences for the lives of thousands of people, depriving them of access to fundamental rights, again undermining the European *acquis* in the field of asylum, and in fact will ensure neither the improvement nor the faster completion of the asylum procedures.

For these reasons, the organizations call on Members of Parliament not to proceed with the voting on the contested provisions of the draft law.

After several months the 16 year old unaccompanied boy that was detained in Amygdaleza prison today was finally released and transferred in a safe and appropriate for his needs place!! 🎉

The story:

The boy called our Helpdesk during March in order to be released from prison. He was more than five months detained as he told us, being transferred from police station to police station and then to the pre removal center of Amygdaleza. His overall emotional state was very crucial. We immediately involved the competent authorities asking for his immediate transfer to a proper shelter. This was followed by concrete legal actions from our side. Shelter was then found in Ritsona. Camp but due to COVID - 19 the transfer could not be made. DCI Greece kept up the communications with the Authorities, submitted additional legal reports. On April the efforts led again to another positive result and a decision was made that the unaccompanied boy will be released and transferred in a safe shelter in Attica. Covid 19 once again acted as an obstacle and in combination with the deficiencies of the Greek asylum system the boy was not transferred immediately. After countless communications and strategic plans, the boy today was finally transferred to the facility!!

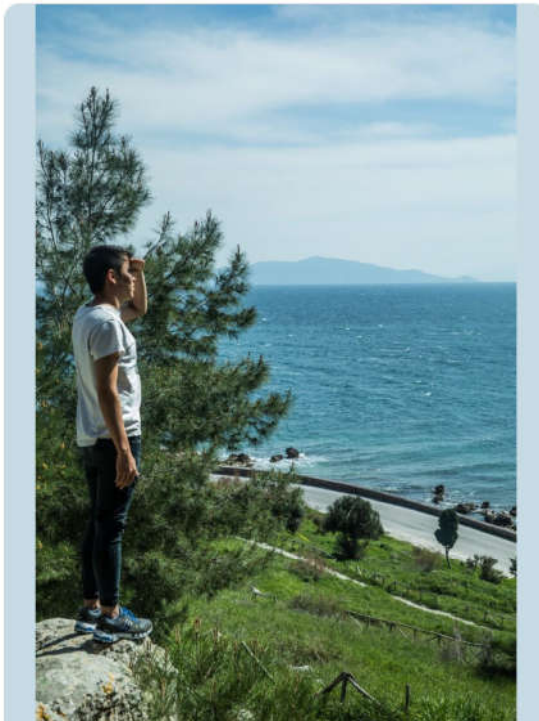

the thematic legal intervention program was designed and launched on the 13th of December 2019. To this day **Defence for Children International Greece** & **Better Days** administered a total of 69 family reunification cases, from which 8 have received a positive answer. In April alone, 2 family reunification cases for Sweden and one for Finland ended successfully. We are now waiting for the destination countries to finalize the minors traveling arrangements; this is the last step of the family reunification process held in Greece and what still separates them from their loved ones.

Restrictions on travel are soon to be lifted which gives us hope and reasons to request the immediate transfer of positive reunification cases from Moria camp. Similarly, when another boy received his positive answer in December, no one anticipated he would still be in Moria 4 months after. He has since endured another 4 months of trauma in an unsafe and toxic environment while his brother lives and waits for him in Holland.

We can't forget. There are 5424 recognized unaccompanied children in Greece of whom over 1000 are homeless or living in unsafe hosting conditions. Leave no one behind.

'Restore legality to protect refugees and the society at large amidst the pandemic'

Athens, 25 March 2020 – Recalling the letter issued on 6 March 2020, signed by more than 250 organizations throughout Europe, the undersigned organizations reiterate the dangers stemming from persisting in current arrangements on the management of the reception of asylum seekers and the respect for their right to seek asylum in Greece. Apart from violating national, EU and international laws, amid the pandemic, these arrangements also pose a major public health danger, arising from overcrowding in Greece's Reception and Identification Centers (RICs) and in the country's detention centers.

Asylum seekers, amongst them many children, who entered Greece with the aim of seeking protection are being detained for the purposes of return, as a result of the Emergency Legislative Decree (E.L.D) issued on 1 March 2020. The E.L.D. has suspended the registration of asylum applications allowing for the immediate deportation of those entering the Greek territory to their countries of origin or Turkey. A large number of refugees and migrants are now being held in prisons and in formal and informal detention centers that keep springing up throughout Greece. This is happening without ensuring minimum standards of hygiene or protection, even during this public health emergency. They are deprived of the right to apply for asylum and are detained under the threat of deportation. In a breach of all international Conventions that protect the right to seek asylum, Greek Courts have imposed severe penalties on them.

We stress that the suspension of the right to seek asylum and the violation of the principle of non-refoulement is an unprecedented abrogation of international obligations in post-war Europe. At the same time, following the Greek Asylum Service's suspension of operations, in the context of social distancing to curb the spread of the coronavirus, the backlog of asylum applications and the uncertainty of asylum seekers who arrived in Greece before the 1st of March are growing daily, as no interim procedures have been defined.

More importantly, the coronavirus pandemic is threatening to affect refugee accommodation sites and camps. The camps, especially on the Aegean islands, suffer from severe overcrowding and lack of adequate sanitary facilities, making it impossible to ensure social distancing and hygiene conditions for both residents and employees. This poses a major threat to public health for both asylum seekers and for society as large. Similarly, the significant increase in the number of third-country nationals placed in administrative detention, in the weeks preceding and especially those following the E.L.D., notwithstanding issues of legality, puts the health of detainees and employees alike at grave risk.

We address all competent Greek authorities, requesting:

- To immediately protect public health with steps designed to protect those residing in camps, camp employees and society at large. The first step should be to urgently decongest the islands, by prioritizing the transfer of those asylum seekers who are most at risk to the Greek mainland or to other EU Member States, in a manner that will protect the health of all involved, as well as public health.
- To rescind the E.L.D, which is due to expire on 2 April 2020; to clarify that refugees who have entered Greece after 1 March 2020 will be granted protection and to suspend deportation decisions that, especially during the pandemic, jeopardize the lives, health, freedom and basic rights of returnees. Reinstating access to asylum, and in particular respecting the principle of non-refoulement, will restore the state of legality.
- To implement alternatives to detention for all administrative detainees throughout Greece, and to prevent ongoing arrests by the police authorities on account of the lack of legal documents for the duration of the pandemic.
- To take all necessary measures to ensure that, even under these emergency conditions, everyone wishing to apply for asylum will be able to do so before the Greek Asylum Service, in a way that safeguards the health of asylum seekers and employees alike.

We once more address the Institutions of the European Union and all member states, requesting:

- To safeguard the right to seek asylum, one of the core rights underlying the fabric of post-war Europe, by exercising their responsibility to ensure all EU member states comply with their international obligations.
- To establish timely and fair relocation mechanisms that will, at minimum, take the most vulnerable, such as children and people with disabilities, away from the Greek islands and into appropriate accommodation within the reach of health services. As this is a health emergency, relocation should be facilitated, keeping only necessary checks to avoid spread of Covid-19.
- To support the Greek Government in its effort to safeguard public health, which can only be achieved through the extensive decongestion of the RICs, the adoption of protective measures that include the population of refugees and migrants, and particularly through avoiding "ghettoization" or generalized detention.

We address the bodies of the Council of Europe and the United Nations, requesting:

- To provide Greece with all possible assistance to avoid the public health crisis that could result, particularly, from the situation in the camps.
- To strengthen the monitoring procedures and oversight for the European Union's and its member states' compliance with International Conventions and International Human Rights Standards.

In closing, we call on everyone to restore legality and be mindful of not neglecting refugees and other vulnerable groups in times of crisis. Prevailing conditions in the camps, coupled with the insurmountable effects of expanding access to asylum, not

compa, coupled with the immediate effects of suspending access to asylum, not only undermine our laws, but can undermine public health in its entirety. These considerations only act to amplify our original plea to restore legality and safeguard our common European system of values.

📍 Athens, 6 March 2020 – The undersigned organisations are deeply concerned about recent developments at the Evros border and the Aegean islands where people are stranded at the borders of Europe, instrumentalized for political purposes, and subject to violations of their rights. We are also deeply concerned about the way the authorities of Greece and the European Union are handling new arrivals. Equally alarming are the extreme actions by security forces against refugees and by civilians against staff of human rights and humanitarian organizations. We would also like to point out that the climate of panic and rhetoric of 'asymmetric threat' –also promoted by the authorities– does not reflect reality and seriously affects not only vulnerable refugees- but also our society and the rule of law as a whole.

Specifically:

We firmly express our opposition to the recent decisions of the Greek Governmental Council on Foreign Affairs and Defense (KYSEA), and in particular the adoption of the Emergency Legislative Decree, which stipulates the suspension of the right to seek asylum for all people entering the country and their return without registration, to their countries of origin or transit. Applying such a regulatory provision is inhumane and illegal as it violates the fundamental principle of non-refoulement, incurs international responsibilities for Greece and endangers human lives. It is beyond dispute that Greece has the sovereign competence to control its borders and to manage any crossings there. Nevertheless, the right to seek asylum is a fundamental human right enshrined in the Universal Declaration of Human Rights and the EU Charter of Fundamental Rights.

We also denounce the attacks on organizations that defend human rights and humanitarian organizations, noting that without the support of these organizations, the refugee management system in Greece would collapse. In addition, solidarity has been stigmatized and become the target of suspicion, which has been also exacerbated by members of the Government, fomenting violence and lawlessness in society in general. We denounce any statements, actions or policies that foment or tolerate bigotry.

We call upon the Greek Government to:

- Withdraw the illegal and unconstitutional Emergency Legislative Decree and to respect the obligations of the Greek State concerning the protection of human life and rescue at sea and at the land borders.
- Immediately stop returning people to states where their lives and freedom are at risk, or where they are at risk of being subjected to torture or other inhuman or degrading treatment or punishment.
- Immediately alleviate overcrowding on the islands by relocating asylum seekers to the mainland, protecting their well-being and health. Priority should be given to the most vulnerable, unaccompanied minors and families with children.
- Take the necessary measures to protect every person from acts of violence, victimization and racism.

We recall that the EU should assume substantial responsibilities for the protection of people on the move in a manner that demonstrates respect for human dignity and

lawfulness and as a matter of shared responsibility among EU member states in the context of managing what is, first and foremost, a European issue. The right to asylum and the respect for the principle of non-refoulement are fundamental elements of international and EU law and therefore the authorities of the European Union must take the necessary measures for their protection.

Therefore:

- The European Commission, as the guardian of the Treaties, should protect the right to asylum as enshrined in EU law. Therefore, it should reverse the “aspidia (shield)” rhetoric used by Greece and urge it to assume its legal obligations.
- EU Member States should re-establish immediately the mechanisms for the relocation of refugees and asylum seekers from Greece to other Member States, in a fair and rational manner, with priority given to unaccompanied children. EU Member States should increase resettlement of refugees directly from Turkey.
- EU Member States and institutions should revise the EU-Turkey Statement, which – in addition to legal lacunae – has now proven to be an unpredictable and unsustainable political tool for border management.

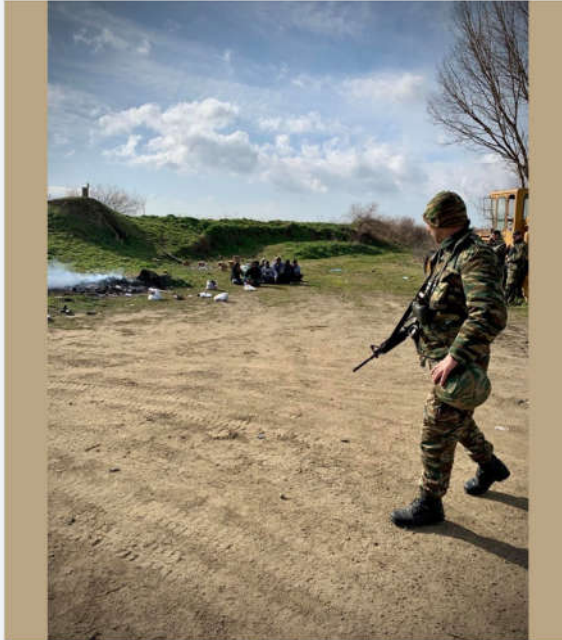
In closing, we call on all sides to respect the law and safeguard European democratic values. Any further backsliding will have major consequences on European societies, European democracy and the rule of law.

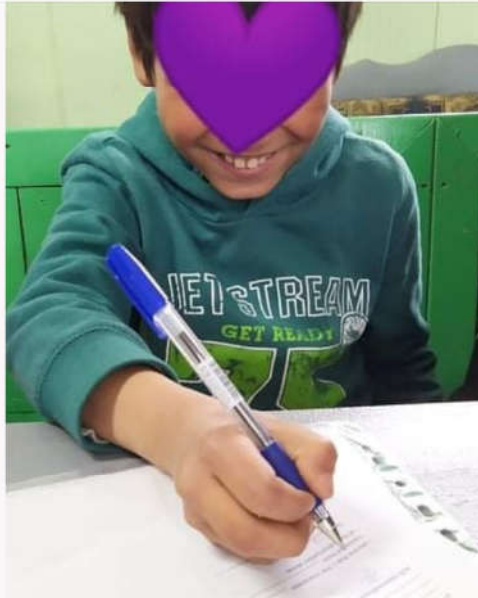

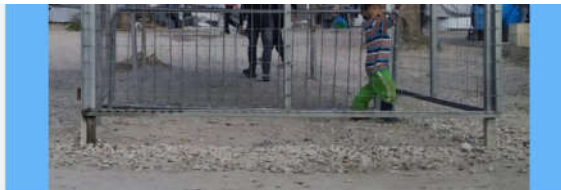

In an open letter to Mr. Kyriakos Mitsotakis, Prime Minister of the Hellenic Republic, DCI Greece and 19 other organisations raise concern over the protection of thousands of unaccompanied children in the country.

Dear Prime Minister,
The organizations signing this letter have been engaged for many years in the field of human rights and humanitarian aid and are looking to you in the hope that you will intercede to resolve a very serious issue. This pertains to the protection of thousands of unaccompanied children, who, due to a lack of suitable and sufficient shelters, as well as a comprehensive guardianship scheme and a system of child protection, remain in unsuitable accommodation and/or detention centers for extended periods of time. It is a common secret that the situation which has taken shape in the last 5 years is not in the best interest of the child. Nor does it benefit our country.

The present letter is sent because of your crucial initiative on November 24, 2019, to prioritize and to bring all the relevant competences under the Prime Minister's office, which we, first and foremost, welcome. We must, however, bring your attention to a set of issues, which have also been underscored by the European Committee of Social Rights and which continue to put at risk the rights and the physical and mental health of unaccompanied children, who arrive in Greece.

Specifically, based on the latest available information provided by the National Centre for Social Solidarity (EKKA) the number of unaccompanied children was 5,463 on January 31, 2020. The prevailing impression is that this figure is obviously an underestimate, given that our organizations continue to identify both cases of non-registration as well as phenomena of incorrect age assessment of refugees and migrants, who have recently arrived. This lack of clarity about the real number constitutes a material impediment for the protection of children in Greece.

At the same time, long-term accommodation places for children continue to be far fewer than those required, in spite of the fact that there was an increase of 182 places in 2019, bringing the total number of places to 1,286 at the end of January 2020. Moreover, an estimated number of 187 children are under detention, which under no circumstances can be considered to be in the best interests of the child, as the practice of "protective custody" has already been ruled by the European Court of Human Rights (ECtHR) as being in breach of the European Convention of Human Rights. In the last year alone, the ECtHR condemned Greece for the protective custody of minors in successive judgments delivered by the Court. Finally, 1,077 unaccompanied children continue to live under precarious conditions or are homeless, with all the risks that this entails for their safety and welfare.

In this context, we would like to underscore that the critical gap, which exists in children's access to safe accommodation is the main, but certainly not the only problem that undermines their protection. Many children continue to be deprived access to basic means of survival, including health services, medical care as well as services of psychosocial and legal support. Moreover, there are unfortunately cases in which children face exclusion from the public education system, in violation, amongst other things, of the International Convention on the Rights of the Child, which has been part of Greek law since 1992.

Finally, we would like to bring to your attention the lack of continuity that short-circuits the Guardianship programme for unaccompanied minors. This programme was carried out until the end of 2019 by non-governmental organisations. Now it has come to an end without ensuring the continued operation of a similar programme. This has created a very serious gap. The new regulatory framework on the guardianship of minors is expected to enter into force on March 1, 2020, in accordance with the relevant provisions of L. 4554/2018 which, after repeated postponements, has been significantly delayed. Today, five days prior to the introduction of the framework, we have not been informed either about the commencement of its operation or the manner in which it will function, causing disquiet and reasonable concerns. In this context, care should be taken to ensure that the institution shall enter into effect immediately, together with other important institutions, such as foster care for minors and we are in a position to put forward specific positions and proposals for their better operation.

Prime Minister,
The Greek State has a moral and legal obligation to actively protect the fundamental rights of unaccompanied minors in Greece according to international and national legislation.

Therefore, we would like to request that you ensure:
The institution and operation of a single system for children's protection, which shall support and protect all children, irrespective of their legal status and origins, until they enter adulthood at least.
The immediate transfer of unaccompanied children from the Reception and Identification Centres on the islands to mainland Greece with a simultaneous increase of the number of places in shelters with special care given to the creation of spaces that are not of a temporary nature and which promote the implementation of alternative housing schemes, such as Semi-Autonomous

supported living schemes.

The implementation of Law 4554/2018 on the guardianship of unaccompanied children as soon as possible, with an immediate provision covering the transitional period until the full implementation of the legal framework, so that children do not remain without a Guardian.

Putting an end to the "protective custody" of children in detention centres, police stations and other facilities throughout Greece, which constitutes a blatant violation of the fundamental rights and has resulted in our country's conviction by the European Court of Human Rights. Moreover, their immediate transfer to appropriate structures.

The obligation to examine requests for international protection of all unaccompanied children, irrespective of age, with the regular rather than the fast track procedure. Taking into account the principle of best interest of children, we are requesting the amendment of the provision of article 75(7) of Law 4636/2019, to include unaccompanied children in the regular procedure.

«Αξιότιμε κύριε Πρωθυπουργέ,

Οι κάτωθι υπογράφουσες οργανώσεις, με πολυετή εμπειρία στους τομείς των ανθρωπίνων δικαιωμάτων και της ανθρωπιστικής προσφοράς, απευθυνόμαστε σε εσάς με την ελπίδα της παρέμβασής σας για την επίλυση ενός πολύ σοβαρού ζητήματος. Αφορά στην προστασία χιλιάδων ασυνόδευτων παιδιών, που ελλείμει κατάλληλων και επαρκών δομών φιλοξενίας, αλλά και ενός ολιστικού σχήματος επιτροπείας και συστήματος παιδικής προστασίας, παραμένουν για παρατεταμένα χρονικά διαστήματα σε ακατάλληλους χώρους διαμονής ή/και κράτησης. Είναι κοινό μυστικό ότι η κατάσταση που έχει διαμορφωθεί τα τελευταία 5 χρόνια δεν συνάδει με το βέλτιστο συμφέρον του παιδιού, ούτε ταιριάζει στη χώρα μας.

Συγκεκριμένα, βάσει των τελευταίων διαθέσιμων στοιχείων του Εθνικού Κέντρου Κοινωνικής Αλληλεγγύης (Ε.Κ.Κ.Α.), ο αριθμός των ασυνόδευτων παιδιών ανερχόταν σε 5.463, την 31/01/2020. Η κρατούσα εντύπωση είναι ότι ο αριθμός αυτός σαφώς υπολείπεται του πραγματικού, δεδομένου ότι οι οργανώσεις μας συνεχίζουν να εντοπίζουν τόσο περιπτώσεις μη καταγραφής όσο και φαινόμενα εσφαλμένης διαπίστωσης της ηλικίας των νεοεισερχόμενων προσφύγων και αιτούντων άσυλο. Αυτή η ασάφεια περί τον πραγματικό αριθμό αποτελεί ουσιαστικό εμπόδιο για την προστασία των παιδιών στην Ελλάδα.

Την ίδια στιγμή, οι θέσεις μακροχρόνιας φιλοξενίας σε κατάλληλες δομές για ανηλικούς συνεχίζουν να υπολείπονται κατά πολύ των αναγκών, παρά το γεγονός ότι έχει καταγραφεί άνοδος κατά 182 θέσεις από το Νοέμβριο του 2019 και αθροίζουν σε 1,286 συνολικές θέσεις στα τέλη Ιανουαρίου 2020. Επιπλέον, ένας εκτιμώμενος αριθμός 187 παιδιών βρίσκονται σε καθεστώς κράτησης, γεγονός που επι' ουδενί μπορεί να θεωρηθεί σύμφωνο με το βέλτιστο συμφέρον του παιδιού, καθώς η πρακτική της «προστατευτικής φύλαξης» ήδη έχει κριθεί από το Ευρωπαϊκό Δικαστήριο Δικαιωμάτων του Ανθρώπου (ΕΔΔΑ) ως αντίθετη στην Ευρωπαϊκή Σύμβαση Δικαιωμάτων του Ανθρώπου. Κατά το τελευταίο έτος μόνο, το ΕΔΔΑ έχει καταδικάσει την Ελλάδα για την «προστατευτική φύλαξη» ασυνόδευτων παιδιών με διαδοχικές αποφάσεις του. Τέλος, 1,077 ασυνόδευτα παιδιά συνεχίζουν να διαβιώνουν σε συνθήκες επισφάλειας ή/και αστεγίας, μια κατάσταση που συνεπάγεται κινδύνους για την ασφάλεια και ευημερία τους.

Σε αυτό το πλαίσιο, θα θέλαμε να επισημάνουμε πως το κρίσιμο κενό της πρόσβασης των ασυνόδευτων παιδιών σε ασφαλή στέγαση, παραμένει το βασικότερο, ίσως, αλλά όχι το μοναδικό πρόβλημα που υπονομεύει την προστασία τους. Πολλά από τα παιδιά εξακολουθούν να στερούνται την πρόσβαση σε βασικά αγαθά επιβίωσης, όπως είναι οι υπηρεσίες υγείας και η ιατροφαρμακευτική περίθαλψη, καθώς και σε υπηρεσίες ψυχοκοινωνικής και νομικής υποστήριξης. Επιπλέον, υπάρχουν δυστυχώς περιπτώσεις που τα παιδιά αντιμετωπίζουν αποκλεισμό από το δημόσιο εκπαιδευτικό σύστημα, κατά παράβαση, μεταξύ άλλων, της Διεθνούς Σύμβασης για τα Δικαιώματα του Παιδιού, η οποία αποτελεί νόμο του ελληνικού κράτους από το 1992.

Τέλος, επιθυμούμε να επιστήσουμε την προσοχή σας στην ασυνέχεια που βραχυκυκλώνει το πρόγραμμα Επιτροπείας ασυνόδευτων παιδιών. Το πρόγραμμα αυτό, μέχρι το τέλος του 2019 το υλοποιούσαν Μη Κυβερνητικές Οργανώσεις. Τώρα πλέον ολοκληρώθηκε, δίχως να ληφθεί μέριμνα για τη συνέχεια λειτουργίας ενός αντίστοιχου προγράμματος. Έτσι δημιουργήθηκε ένα πολύ σοβαρό κενό. Την 1η Μαρτίου 2020 προβλέπεται η έναρξη εφαρμογής του νέου ρυθμιστικού πλαισίου για την επιτροπεία ασυνόδευτων παιδιών σύμφωνα με τις σχετικές διατάξεις του ν. 4554/2018 που ήδη έχει καθυστερήσει σημαντικά, έπειτα από αλληπαλλήλες αναβολές. Σήμερα, 5 ημέρες πριν την έναρξη του

πλαίσιο, δεν έχουμε λάβει περαιτέρω ενημέρωση ούτε για την έναρξη, ούτε και για τον τρόπο λειτουργίας του, γεγονός που δημιουργεί ανησυχίες και εύλογους προβληματισμούς. Στο πλαίσιο αυτό, απαιτείται να υπάρξει η μέριμνα προκειμένου ο θεσμός αυτός να τεθεί σε εφαρμογή άμεσα, παράλληλα με άλλους σημαντικούς θεσμούς, όπως η αναδοχή ανηλίκων, για την καλύτερη λειτουργία των οποίων είμαστε σε θέση να διατυπώσουμε συγκεκριμένες θέσεις και προτάσεις».

Οι 19 οργανώσεις ζητούν ακόμη από τον πρωθυπουργό να μεριμνήσει για:

- Τη θεσμοθέτηση και λειτουργία ενιαίου συστήματος παιδικής προστασίας, το οποίο θα υποστηρίζει και προστατεύει όλα τα παιδιά, ανεξαρτήτως του νομικού καθεστώτος και της καταγωγής τους έως τουλάχιστον την ενηλικίωσή τους.
- Την άμεση μεταφορά όλων των ασυνόδευτων παιδιών από τα Κέντρα Υποδοχής και Ταυτοποίησης των νησιών στην ενδοχώρα και την παράλληλη αύξηση των θέσεων στέγασης σε δομές φιλοξενίας, με ιδιαίτερη μέριμνα για τη δημιουργία χώρων μη προσωρινού χαρακτήρα και την προώθηση της εφαρμογής των σχημάτων εναλλακτικής στέγασης, όπως της Υποστηριζόμενης Ημι-Αυτόνομης Διαβίωσης και της αναδοχής.
- Την εφαρμογή του Νόμου 4554/2018 για την επιτροπεία ασυνόδευτων παιδιών το συντομότερο δυνατό, με άμεση πρόβλεψη για την κάλυψη της μεταβατικής περιόδου μέχρι την πλήρη εφαρμογή του νομικού πλαισίου, ώστε τα παιδιά να μην μένουν χωρίς Επίτροπο.
- Τον τερματισμό της "προστατευτικής φύλαξης" των παιδιών σε κέντρα κράτησης, αστυνομικά τμήματα και άλλες εγκαταστάσεις σε όλη την Ελλάδα, οι οποίες συνιστούν κατάφωρη παραβίαση θεμελιωδών δικαιωμάτων και έχουν οδηγήσει τη χώρα μας σε καταδίκες από το Ευρωπαϊκό Δικαστήριο Δικαιωμάτων του Ανθρώπου. Επίσης, την άμεση μεταφορά τους σε κατάλληλες δομές φιλοξενίας, χωρίς προσωρινό χαρακτήρα.
- Την υποχρέωση εξέτασης των αιτημάτων διεθνούς προστασίας όλων των ασυνόδευτων παιδιών, ανεξαρτήτως ηλικίας, με την κανονική και όχι την ταχύρρυθμη διαδικασία. Λαμβάνοντας υπόψη την αρχή του βέλτιστου συμφέροντος των παιδιών, ζητάμε την τροποποίηση της διάταξης της παραγράφου 7 του άρθρου 75 του Νόμου 4636/2019, ώστε να συμπεριληφθούν όλα τα ασυνόδευτα παιδιά στην κανονική διαδικασία.

👉 Furthermore, we call the government to ensure access to a fair asylum process, and to immediately decongest the islands, which will be beneficial for both refugees and local communities. In order for this to be achieved, rationality and co-operation with all bodies involved in refugee management must prevail.

Children even younger than Mahmood, sleep out in the forest without safe access to water and food.

They remain invisible, traumatized and unprotected while the majority of them have family members in other EU countries.

During our latest mission, in December 2019, on the island, we spoke and supported many of them.

They all asked for a safe place to sleep away from the danger of being stabbed or attacked. They made sure we understood that moving inside the Moria Camp would not be a safe option either.

In the weeks that followed our meeting with them, many incidents of minors being stabbed or harassed during the night came as a confirmation to their worry.

The trapped children inside and outside Moria Camp can foresee the next deaths to follow.

All they ask is 'Europe CAN YOU HEAR US?'

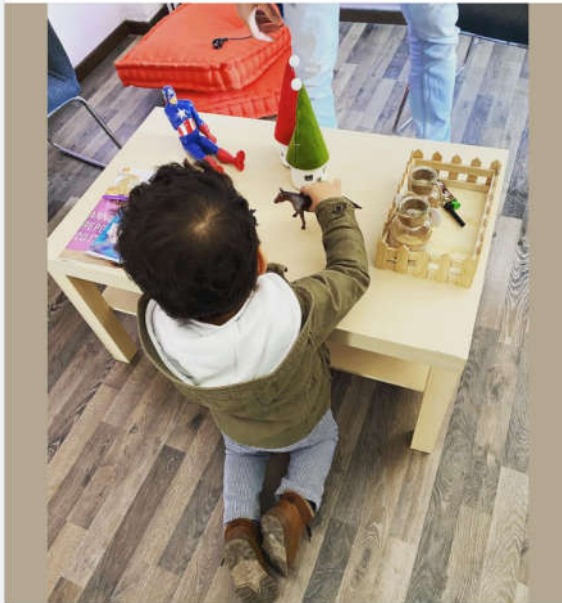

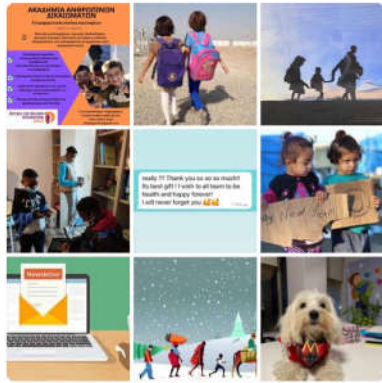

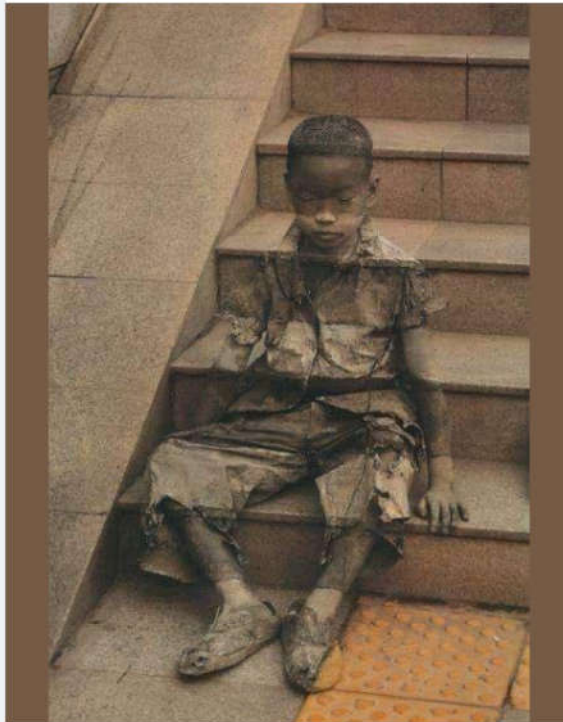
